BeWell Stakeholder meeting

Be Well Stakeholder Discussion

1. Will 1212 California be abandoned?

No. The Be Well Center will be in addition to 1212 California.

- 2. You stated 200 new staff members will be needed. How many of those are clinical vs. admin? Each building has its own feasible study completed dependent on what services are in that building
- 3. Will they have to go to St. Joe's for med clearance? No. med clearance will be on site. Only those at 1212 will have to go to St. Joe's for med clearance
- 4. Is any of the current \$203 mil going to phase II?

No. The current funds being raised is going towards the four buildings in phase I.

- 5. How are you going to make people want to go there?
 - We are looking for feedback as we go along so we can not have the stigma we do now. We want to be good neighbors.
- 6. If there is no other facility like this in Northern CA, are you prepared for numbers to come? Yes. Sacramento, Fresno and Yolo will pay for our beds. Right now there is not enough space /beds so individuals get stuck in the system.
- 7. Is there a priority for people in San Joaquin County?

Yes. SJC residents get priority.

8. Do we have enough doctors?

Yes. NIC contract; full continuum of psychiatrists, telehealth and in person

9. How many of the providers will have lived experience?

That will be part of the criteria.

10. How will this affect VA services?

Trying to work it out so VA benefits can be used for crisis services.

11. How does Recovery House tie in?

Will still be a partner.

12. Is there a need?

Currently youth substance and residence have to go to LA. This will be the only facility north of the grapevine.

13. Having two crisis and two PHF units, how will they work together? Don't know yet. BeWell will be co-occuring.
