III. Opioid Settlement Stakeholder meeting:

- Janssen and distributors settlement funds
- First settlement agreement reached in California in July, 2021
- Funds are compensation to communities for harm done by the opioid epidemic.
- Funds are to be used for the abatement of the opioid epidemic in CA.
- The total CA settlement amount is an estimated \$2.2 billion.
- Distributions will be to state, county, and municipal jurisdictions.
- 15 % is allocated to State, 70% to Cities and Counties, and an additional 15% will go to Cities and Counties after litigation costs are paid.
- DCHS Allowable Expenditures
 - ♦ 50% of Money must be focused on HIAA
- Core Strategies
 - ♦ Naloxone & Other Overdose Reversal Drugs
 - ♦ Medication-Assisted Treatment (MAT)
