- Classes have been great at the Gipson Center
- Having a wellness center somewhere to get help for free
- Assistance around benefits has been working for us
- NAMI has been great support to train the community
- Peer Support being part of recovery is important
- 1212 Clinic referring clients to Wellness Center
- CAC is helpful for consumers to engage leadership and empowerment skills

- People are more receptive to services
- Less Stigma in some communities

#### **What Needs Improvement?**

- Need more MH Advocates in the community
- Support Services through the health plans
- BHS needs to hire more therapists than case managers
- Need more groups especially dual diagnoses, self care, WRAP, and recovery groups
- Group Therapy needs
- More uplifting reception area in crisis messages of Hope, empowerment, etc.
- Reception in 24hour services are not friendly Staff not showing empathy skills (adding fuel to the fire)
- Bridge services between crisis and outpatient dedicated staff to do this
- Family outreach/education and support
- Prevention and education services for Older adults
- Safe Spaces for LGBTQ+ Youth
- Services for Lodi area (not enough or not marketed enough)
- Offsite meetings for Consortium throughout the community, possibly quarterly
- Website design/redesign outdated
- Working with Punjabi population in Lodi
- Meeting consumers where they are, not assuming what the client needs are.
