◆ BHS's Justice and Decriminalization Unit works in partnership with San Joaquin County Jail, Correctional Health Services, the Collaborative Court System, the Probation Department, and other justice agencies, to provide a full spectrum of mental health services to consumers who are engaged by the criminal justice system.

♦ Target Population

- ♦ Justice Involved Adults 18 and over
- With serious and persistent mental illness who are being treated by Correctional Health Services within the San Joaquin County Jail and are within 30 days of release into the community.
- ♦ With a diagnosed mental illness or co-occurring substance use disorder, who are participating in problem solving, collaborative courts in San Joaquin County or other formal diversion programs.

♦ TARGET POPULATION

◆ Black Awareness Community Outreach Program/Multicultural Services (BACOP/MC) opened in April 2006. The primary focus is on reaching out to and serving the unserved, underserved, or inappropriately served residents of San Joaquin County with severe mental illness. Although our goal is to respond to those individuals who are African American, Native American, Middle Eastern American or LGBTQIA, any persons may seek mental health services at BACOP/MC.

OPROGRAM REQUIREMENTS

- ♦ Ages 18 and older
- ♦ Have a diagnosis of a serious mental illness that causes moderate to severe impairments in daily living. Willingness to engage in and receive services.
- ♦ Medi-Cal beneficiary, Medi Medi or no insurance

VII. COMMITTEE REPORTS:

• Legislative Report – Gertie Kandris

PRESIDENT BIDEN signed into law the Consolidated Appropriations Act of 2023 an approximately \$1.7 trillion spending package which consists all of fiscal year 2023 appropriations bills and funds the federal government through September 30, 2023. It includes funding for numerous mental health and substance use disorder programs and implements federal mental health parity requirements.

STATUS OF CURRENT CALIFORNIA LEGISLATION

AB 21 Assembly Member Gipson Current law requires specified categories of law enforcement officers to meet training standards pursuant to courses of training to effectively interact with persons with mental illness or intellectual disability. This Bill requires the commission to revise that training to include instruction on how to effectively interact with persons with Alzheimer's disease or dementia.

SB 47 Senator Roth Current Child Abuse and Neglect Reporting Act requires a mandated reporter to report whenever they know or reasonably suspect that a child has been the victim of child abuse or neglect. Current law also authorizes any other person to report known suspected child abuse or neglect. Under current law, reports of

suspected child abuse or neglect are made to any police department, sheriff's department, county probation department, if designated by the county to receive mandated reports, or county welfare department. This Bill would require an agency that receives a report of known or suspected child abuse to take specified action including requiring an investigator to contact the person making the report and to visit the child in person to determine if the child should be removed from the home during the pendency of an investigation into a report of child abuse or neglect.
